SUBJECT : NOTICE OF FAILURE OF ITB No. COR 14-00212

This refers to the Negotiated Procurement (Small Value) for the **RENTAL OF BASKETBALL COURTS FOR HRDD-TDU** under **ITB No. COR 14-00212** with an Approved Budget for the Contract (ABC) in the amount of One Hundred Sixty Six Thousand Eight Hundred Pesos (Php 166,800.00) - VAT Exclusive, Zero Rated Transaction.


On the deadline for the Submission and Receipt of Quotations held on January 09, 2015 at 2:00 PM, two (2) bidders submitted their quotations for the said project, **Olivarez Sports Center** and **Pearl Sports Center**. After the preliminary examination of the submitted quotations, results obtained are as follows:

On January 12, 2015, Olivarez Sports Center was notified to submit within three (3) working days the required documents for post qualification process. Unfortunately the supplier failed to submit within the prescribed period indicated in the letter; thus a "Notice of Disqualification" letter was issued to the same last January 23, 2015. Likewise, Pearl Sports Center was also notified to submit the required documents last January 26, 2015 and a "Notice of Disqualification" letter was also issued for failure to comply with the said requirements. No motions for reconsideration were received by PAGCOR from both suppliers.

In view of the foregoing, the Procurement & Property Department - urchasing Unit respectfully recommends for the information or further instructions, if any, of the Assistant Vice President-Procurement & Property Department, as duly delegated by the Board of the Directors a declaration of a "**Failure**" of Negotiated Procurement (Small Value) of **RENTAL OF BASKETBALL COURTS FOR HRDD-TDU** covered by **ITB No. COR 14-00212** pursuant to Section 35.1 of the IRR of R.A. No. 9184.
