This refers to the Negotiated Procurement (Small Value) of **SERVICES FOR REPAIRS AND MAINTENANCE OF VARIOUS MOTOR VEHICLES FOR SIX (6) MONTHS PERIOD** under ITB No. **COR 15-00040** with an Approved Budget for the Contract (ABC) in the amount of **Four Hundred Ninety Five Thousand Pesos (Php 495,000.00)** - VAT Exclusive, Zero Rated Transaction.

On the deadline for the Submission and Receipt of Quotations held last April 13, 2015 @2:00 PM, two (2) bidders were able to submit their quotations for the said project.

After the preliminary examination of the submitted quotations, results obtained are as follows:

On April 14, 2015, "Notice of Disqualification" letters were issued to **CAPITAL INDUSTRIES, INC.** and **F.B. LADAO SALES, INC.** for their failure to bid in one of the items in the Service Description which is included as One (1) Lot for the above stated project. No Motion for Reconsideration was received by PAGCOR.

In view of the foregoing, the Purchasing Unit - Procurement and Property Department respectfully recommends the following for the information or further instructions, if any, of the Assistant Vice President-Procurement and Property Department, as duly delegated by the Board of the Directors:

1. Declaration of a **"Failure"** of Negotiated Procurement (Small Value) for the PROCUREMENT OF SERVICES FOR REPAIRS AND MAINTENANCE OF VARIOUS MOTOR VEHICLES FOR SIX (6) MONTHS PERIOD under ITB No. COR 15-00040 pursuant to Section 35.1 of the IRR of R.A. No. 9184; and,
2. Re-conduct of Negotiated Procurement thru Small Value for the PROCUREMENT OF SERVICES FOR REPAIRS AND MAINTENANCE OF VARIOUS MOTOR VEHICLES FOR SIX (6) MONTHS PERIOD after the re-evaluation of the project's requirements.
