



This PURCHASE CONTRACT (the "CONTRACT") is entered into and executed by and between:

PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR), a government owned and controlled corporation created and existing by virtue of Presidential Decree 1869, as amended, with office address at the Procurement Department, 8th Floor, PAGCOR House Annex, 1105 United Nations Avenue cor. Maria Orosa Street, Ermita Manila represented in this act by its Assistant Vice President, Procurement Department, **HERNANDO C. APIGO**, hereinafter referred to as "**PAGCOR**";

A4 LUCK MARKETING CORPORATION a corporation duly organized and existing under the laws of the Republic of the Philippines, with office address at 67 A. Mabini St., San Pedro, Laguna, represented in this act by its President, **MICHAEL R.
