- b. Certified True Copy of the Income and/or Business Tax Returns either filed and paid manually or electronically through the Electronic Filing and Payment System of the BIR per E.O. 398, RR-03-2005 and RMC 16-2005;
- c. Philippine Government and Electronic Procurement System (PhilGEPS) Registration Certificate; and
- d. Valid FAGCOR Registration Certificate.

To guarantee the faithful performance of all your obligations under the contract, PAGCOR shall secure five percent (5%) retention money from the service fee, which shall not exceed the total amount of Seventeen Thousand Five Hundred Pesos (PHP 17,500.00). The performance security shall remain valid until issuance of the final Certificate of Acceptance.
