We are pleased to inform you that the Ordering Agreement for the Supply and Delivery of Relief Goods – Food Items through Ordering Agreement under ITB No. FB18-10-026COR that was awarded to you has already been formally signed by the duly designated PAGCOR official and your representative.

All notices called for by the terms of the Ordering Agreement shall be effective only from the date of receipt of this notice.

When PAGCOR has determined the necessity for the supply and delivery of the sando bag/s of relief goods, it shall require the delivery of the requirement identified in the Order Agreement List by executing a Delivery Order Contract in your favor to supply and deliver said items according to the terms and conditions stated in the Ordering Agreement.

The required quantity of the item/s enumerated in the Order Agreement List shall be delivered within five (5) calendar days upon receipt of the Delivery Order Contract from the end-user/Community Relations and Services Department (CRSD).

PAGCOR may execute as many Delivery Order Contracts as may be needed within the validity period of six (6) months of the Ordering Agreement; provided that subsequent Delivery Order Contracts shall have the same unit price as originally stated in the Ordering Agreement and shall not exceed the estimated quantity in the Order Agreement List.


