

PURCHASE CONTRACT

This PURCHASE CONTRACT (the "CONTRACT") is entered into and executed by and between:

PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR), a government-owned and controlled corporation created and existing by virtue of Presidential Decree 1869, as amended, with office address at the PAGCOR Executive Office, Fifth (5th) Floor, New World Manila Bay Hotel, M.H Del Pilar cor. Pedro Gil Sts. Malate, Manila, represented in this act by its Branch Manager, **Mr. RICARDO L. UY**, as duly delegated by the Board of Directors, hereinafter referred to as "**PAGCOR**";

-and-

R.A. MERCHANDISE & DELICACIES sole proprietorship, with office address at R. Duterte St., Banawa, Cebu City, represented in this act by its Proprietor, **MR. RICHARD ANTHONY C. YBANEZ**", hereinafter referred to as the "**SUPPLIER**".

Both **PAGCOR** and the **SUPPLIER** may be referred to as the "PARTY" or the "PARTIES" collectively.
