This PURCHASE CONTRACT (the "CONTRACT") is entered into and executed by and between:

Pedro Gil Sts. Malate, Manila, represented in this act by its Branch Manager, **Mr. RICARDO L. UY**, hereinafter referred to as "**PAGCOR**";

HOLISTER INC., a corporation duly organized and existing under the laws of the Republic of the Philippines, with office address at 9th Floor, Trends Plaza Bldg, F. Ramos St. Cogon Central, Cebu City, represented in this act by its Operations Manager, **Ms. MARY ROSE O. FAJARDO**, duly authorized for this purpose by **Ms. MA. LOURDES S. GO**, Corporate Secretary dated December 3, 2018, hereto attached as Annex "A", hereinafter referred to as the "**SUPPLIER**".
