- B. For casinos whose importations are covered by an Import Permit filed with a Special Economic Zone Authority:

- For Licensed Casinos whose importation availed of PAGCOR's customs and duties tax exemptions, permanent decommissioning shall not be carried out unless PAGCOR has obtained a written approval from the DOF.
