- (c) If suspension affects some gaming terminals only at any given time, a project timetable shall be attached to this form signifying the schedule of terminal suspension in the affected areas.
- (d) The Operator shall notify EG/EBLD using Installation and/or Operation of Electronic Gaming/Betting/Bingo Terminals/Machines Notification Form (GS Form No. 8-A) of the installation
