Please be advised that the PAGCOR Board of Directors approved in its meeting on January 12, 2017 the implementation and inclusion of amendments to Regulations 5 and 7 of the following regulatory manuals regarding the conduct of site inspection of the gaming site by PAGCOR authorized team:

1. Gaming Site Regulatory Manual version 2.2 (Electronic Games);
2. Gaming Site Regulatory Manual version 2.2 (Bingo Games); and
3. Gaming Site Regulatory Manual version 1.0 (Poker Games)

PAGCOR authorized team shall be comprised of the representatives from GLDD and CMED. The following amendments can now be viewed or downloaded from the corresponding "Amendment" link at "Electronic Gaming & Poker" page through "Regulatory" page of the PAGCOR website:

(c) PAGCOR authorized team may conduct a final inspection of the gaming site, as it deems necessary, prior to its gaming operation.	(c) PAGCOR authorized team will conduct final inspection of the gaming site prior to its gaming operation.

4. Subsection (b) of Section 11 (Other pre-operational activities) under Regulation 7 (The Gaming Site) of GSRM for Poker Games

(b) PAGCOR authorized team may conduct a final inspection of the gaming site, as it deems necessary, prior to its gaming operation.	(b) PAGCOR authorized team will conduct final inspection of the gaming site prior to its gaming operation.
