  - Completely filled out Application Form for Renewal
  - Latest General Information Sheet (GIS)
  - Updated Notarized Personal Disclosure Statements (PDS) of Authorized Representative, President, Corporate Secretary and Treasurer of the company
  - If there are material changes in the corporate structure:
    - a. New Organizational Chart indicating names of the person/s occupying the position/s
    - b. Board Resolution or Secretary's Certificate appointing new Authorized Representative
    - c. Specimen Signature Card of new Authorized Representative
  - Letter of No Objection (if applicable)
  - Lease Agreement / Proof of Ownership of Operating Site (if applicable)
